Updated Clearance Requirements

How volunteers can get cleared to work with your school, in-person or virtually!

What does volunteer clearance mean for my school?

The state of CA and OUSD legal require different levels of clearance to be filed for different types of volunteering.

We are here to help navigate this nuance and simplify the onboarding process for all volunteers!

Once volunteers register, we carry them through the process to obtain the clearance that's right for them.

Our Goals!

- 1. Present you with live, up-to-date information about who is cleared to do what at your school site through the database.
- 2. Effectively communicate the levels of clearance and how to obtain them so they you may help volunteers who stall out during the onboarding process.

Updates for the 2021-22 School Year

What's the **Same**:

DOJ/FBI Fingerprinting(Live Scan) - Required for all volunteers who:

- Are assigned to support OUSD online education,
- Parents/guardians who volunteer in-person while unsupervised, and
- All community members who volunteer on an ongoing basis.

Tuberculosis (TB) Clearance - Required for all in-person volunteers who volunteer 3+ times a school year. Clearance is valid for 4 years.

What's <u>New</u> for In-Person:

VACCINATION - All in-person volunteers are required to submit proof of vaccination against COVID19 to be approved for in-person service.

COVID WAIVER - All in-person volunteers must sign a new waiver acknowledging the risk of in-person service and contracting the COVID 19 virus.

How it Works!

Where volunteers need to start:

1st time volunteers:	Register on our website: www.oaklandedfund.org/volunteer/
Returning volunteers:	Check their status online to update expired or missing requirements: www.oaklandedfund.org/volunteer/


- → Once volunteers are in our system, we send them automatic instructions, confirmations, and next steps to carry them throughout the onboarding process. osv@oaklandedfund.org
- → We work hard to communicate their options and next steps clearly and concisely.
- → Our materials are available in English and Spanish. We also have additional materials available in Arabic, Chinese, and additional languages upon request. We are working to update into more languages, but this is still coming soon given how many changes the pandemic has brought to clearance requirements.







Practical Application

Helping people complete the process!

Helping people finish their clearance:

OPTION A: Parents/Guardians <u>Check Their Own</u> Status

- 1. Parents/guardians can view their volunteer status on our website: https://www.oaklandedfund.org/parent-volunteers/
- 2. Select "Check your existing volunteer status here", type in their information, and view results.
- 3. Parents/guardians are prompted to update their information by using this link as well.

OPTION B: Educators Can Use The Database

If a volunteer is listed as either a "Community Applicant" or "Parent Applicant", you can learn what they need to do to complete their volunteer clearance by visiting their "contact record".

- 1. Click on the name of the applicant. This will take you to a new page with information unique to this particular individual.
- 2. Scroll down to the section entitled "Clearance Information" to see what is missing.
